SECTION 4: First aid measures

5.3 Advice for firefighters

Special protective actions for fire-fighters

8.2 Exposure controls

Appropriate engineering controls

: Provide adequate ventilation. Where reasonably practicable, this should be achieved by the use of local exhaust ventilation and good general extraction.
