##### 4.1. Description of first aid measures

###### General information

Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Never give anything by mouth to an unconscious person.

#### Usage precautions

Keep away from heat, sparks and open flame. Avoid spilling. Avoid contact with skin and eyes. Avoid inhalation of vapours and spray mists. Do not eat, drink or smoke when using the product. Good personal hygiene procedures should be implemented. Wash hands and any other contaminated areas of the body with soap and water before leaving the work site. The Manual Handling Operations Regulations may apply to the handling of containers of this product. To assist employers, the following method of calculating the weight for any pack size is given.
