

## PAINTS FOR CORROSION PROTECTION OF STRUCTURAL STEELWORK IN HIGHWAY APPLICATIONS

### JOTAMASTIC 90 B16 – TO HE ITEM NO 116

This HAPAS Certificate Product Sheet<sup>(1)</sup> is issued by the British Board of Agrément (BBA), supported by Highways England (HE) (acting on behalf of the Overseeing Organisations of the Department for Transport; Transport Scotland; the Welsh Government and the Department for Infrastructure, Northern Ireland), the Association of Directors of Environment, Economy, Planning and Transport (ADEPT), the Local Government Technical Advisers Group and industry bodies. HAPAS Certificates are normally each subject to a review every three years.

(1) Hereinafter referred to as 'Certificate'.

This Certificate relates to Jotamastic 90 B16, a two-pack, epoxy maintenance undercoat for abraded surfaces, for use as part of a specification for the corrosion protection of structural steelwork in Highway Applications, in accordance with the *Manual of Contract Documents for Highway Works* (MCHW), Volumes 1 and 2, where Item No 116 is specified.

#### KEY FACTORS ASSESSED

**Corrosion resistance** — a complete paint system incorporating the product will provide satisfactory resistance to corrosion of the substrate steel (see section 6).

**Durability** — a complete paint system based on the products described in this Certificate can be expected to perform satisfactorily for a period in excess of 15 years before its first major maintenance (see section 8).

## Requirements

In the opinion of the BBA, Jotamastic 90 B16, having been registered by Highways England and found to comply with the requirements of CG303 (formerly BD 35/14) and approved for ongoing registration, when used in accordance with the provisions of this Certificate will satisfy or contribute to satisfying the requirements of the:

- MCHW<sup>(1)</sup>, Volume 1 (Paints), Series 1900 and 5000
- MCHW<sup>(1)</sup>, Volume 2, Series NG 1900 and NG 5000
- *Design Manual for Roads and Bridges* (DMRB), CG303 *Quality assurance scheme for paints and similar protective coatings*
- CM 431, formerly BD 87/05.

## Technical Specification

### 1 Description

1.1 Jotamastic 90 B16 is a two-pack, epoxy maintenance undercoat for abraded surfaces, for use as part of a specification for the corrosion protection of structural steelwork in Highway Applications, in accordance with the MCHW, Volumes 1 and 2, where Item No 116 is specified. The product is available in a range of colours. Standard and winter grades are available.

1.2 The product has the following characteristics:

### 2 Manufacture

2.1 The product is manufactured by a batch-blending process.

2.2 As part of the assessment and ongoing surveillance of product quality, the BBA has:

- agreed with the manufacturer the quality control procedures and product testing to be undertaken
- assessed and agreed the quality control operated over batches of incoming materials
- monitored the production process and verified that it is in accordance with the documented process
- evaluated the process for management of nonconformities
- checked that equipment has been properly tested and calibrated
- undertaken to carry out the above measures on a regular basis through a surveillance process, to verify that the specifications and quality control being operated by the manufacturer are being maintained.

2.3 The management system of the manufacturer has been assessed and registered as meeting the requirements of BS EN ISO 9001 : 2015 by Intertek (Certificate 0044915-05).

### 3 Delivery and site handling

3.1 The product is supplied in 5 and 20 litre packs in the correct proportions and the gross weight of the mixed containers is 6.96 and 30.35 kg respectively.

3.2 The Certificate holder has taken the responsibility of classifying and labelling the product under the *CLP Regulation (EC) No 1272/2008 on the classification, labelling and packaging of substances and mixtures*. Users must refer to the relevant Safety Data Sheet(s).

3.3 When stored in the original containers in a paint store, in the conditions recommended by the Certificate holder, the product has a minimum shelf-life of 4 years.

## Assessment and Technical Investigations

The following is a summary of the assessment and technical investigations carried out on Jotamastic 90 B16.

### Design Considerations

## 4 Use

4.1 Where included as part of the specification for a paint system as listed in the *Supplement to Paints for Corrosion Protection of Structural Steelwork in Highway Applications*<sup>(1)</sup>, Jotamastic 90 B16 is satisfactory for use over steelwork prepared by abrasive blast cleaning to a minimum standard of Sa 2½ to BS EN ISO 8501-1 : 2007, primed with Jotamastic B15 (which meets Item 115).

(1) Product Sheet 99 of this Certificate.

4.2 The product may also be considered for use over steels prepared to surface standard St3 (to BS EN ISO 8501-1 : 2007 and BS 7079 : 2009), and primed with Jotamastic B15, or over suitably prepared sound weathered coatings. However, in these applications the durability of the complete paint system based on the products described in this Certificate will be dependent on the standard of surface preparation actually achieved and, where applicable, the integrity of any existing coatings.

## 5 Practicability of installation

Application of the product is designed to be carried out by operatives familiar with this type of product.

## 6 Corrosion resistance

The product has been registered in accordance with the requirements of CG303 and can contribute to corrosion resistance when included as part of the specification for a paint system as listed in the *Supplement to Paints for Corrosion Protection of Structural Steelwork in Highway Applications*.

## 7 Maintenance

Regular planned maintenance may be required as per section 8. Damage must be repaired in accordance with the MCHW, Volume 1 (Paints), Series 5000.

## 8 Durability

A complete paint system based on the products described in this Certificate can be expected to perform satisfactorily for a period in excess of 15 years before its first major maintenance.

## Installation

### 9 Application

9.1 Substrates must be cleaned and prepared in accordance with the MCHW, Volume 1 (Paints), Series 1900 and 5000, and the Certificate holder's instructions.

9.2 The base (Part A) is mixed with a power agitator, after which the entire contents of the curing agent (Part B) are added, and the product mixed thoroughly.

9.3 The product is applied by airless spray (tip range 0.75 to 0.98 mm, output fluid pressure not less than 15 MPa/min) or air-assisted spray, to achieve a typical dry film thickness (dft) of between 100 to 300 µm [equivalent to a wet film thickness (wft) of 125 to 375 µm]. The Certificate holder can advise on suitable spray equipment.

9.4 Small areas can be coated by brush or roller, if required.

9.5 The product is overcoated with the Certificate holder's products bearing the appropriate HAPAS-approval, observing the minimum overcoating period given in Tables 2 and 3.

9.6 The product must be used within the pot life given in Tables 2 and 3.

- hard dry
- application and appearance
- minimum overcoating time
- film thickness
- complete system
  - artificial weathering of topcoat
  - scratch resistance of single-pack topcoat and of two-pack topcoat
  - impact resistance
  - adhesion for systems of thicknesses <250 and >250 µm
  - salt spray
  - sulphur dioxide
  - humidity.

## 11 Investigations

The manufacturing process was evaluated, including the methods adopted for quality control, and details were obtained of the quality and composition of the materials used.
