# SIGMA EP 110 PRIMER – TO HE ITEM NO 110

This HAPAS Certificate Product Sheet<sup>(1)</sup> is issued by the British Board of Agrément (BBA), supported by National Highways (NH) (acting on behalf of the Overseeing Organisations of the Department for Transport; Transport Scotland; the Welsh Government and the Department for Infrastructure, Northern Ireland), the Association of Directors of Environment, Economy, Planning and Transport (ADEPT), the Local Government Technical Advisers Group and industry bodies. HAPAS Certificates are normally each subject to a review every three years.

(1) Hereinafter referred to as 'Certificate'.

This Certificate relates to Sigma EP 110 Primer, a two-pack zinc phosphate, epoxy blast primer/sealer for use as part of a specification for the corrosion protection of structural steelwork in highways applications, in accordance with the *Manual of Contract Documents for Highways Works* (MCHW), Volumes 1 and 2, where Item No 110 is specified.

## **KEY FACTORS ASSESSED**

**Corrosion resistance** — a complete paint system incorporating the product and described in Product Sheet 99 will provide satisfactory resistance to corrosion of the substrate steel (see section 6).

**Durability** — a complete paint system incorporating the product can be expected to perform satisfactorily for a period in excess of 15 years before its first major maintenance (see section 8).

The BBA has awarded this Certificate to the company named above for the product described herein. This product has been assessed by the BBA as being fit for its intended use provided it is installed, used and maintained as set out in this Certificate.



## **Technical Specification**

## **1** Description

1.1 Sigma EP 110 Primer is a two-pack, zinc phosphate, epoxy blast primer for use as part of a specification for the corrosion protection of structural steelwork in Highway Applications, in accordance with the MCHW, Volumes 1 and 2, where Item No 110 is specified. The product is available in a buff colour.

1.2 The product has the following characteristics:

1.3 Other products for use as part of the complete paint system are given in Product Sheet 99.

# 2 Manufacture

2.1 The product is manufactured by a batch-blending process.

2.2 As part of the assessment and ongoing surveillance of product quality, the BBA has:

- agreed with the manufacturer the quality control procedures and product testing to be undertaken
- assessed and agreed the quality control operated over batches of incoming materials
- monitored the production process and verified that it is in accordance with the documented process
- evaluated the process for management of nonconformities
- checked that equipment has been properly tested and calibrated

• undertaken to carry out the above measures on a regular basis through a surveillance process, to verify that the specifications and quality control being operated by the manufacturer are being maintained.

2.3 The management system of the manufacturer has been assessed and registered as meeting the requirements of BS EN ISO 9001 : 2015 by Bureau Veritas (Certificates FR052652 and FR045407).

# **3** Delivery and site handling

3.1 The product is supplied in either a 4 or 20 litre pack, each of which contains the correct proportions of each component. The gross weight of the mixed 4 litre container is 5.8kg and 20 litre container is 28 kg.

3.2 The Certificate holder has taken the responsibility of classifying and labelling the product under the *CLP Regulation (EC) No 1272/2008 on the classification, labelling and packaging of substances and mixtures.* Users must refer to the relevant Safety Data Sheet(s).

3.3 When stored in its original containers in a paint store in the conditions recommended by the Certificate holder, the product will have a minimum shelf-life of 12 months.

## 4 Use

Where included as part of the specification for a paint system as listed in the *Supplement to Paints for Corrosion Protection of Structural Steelwork in Highways Applications*<sup>(1)</sup>, Sigma EP 110 Primer is satisfactory for use as a primer for steelwork prepared by abrasive blast cleaning to a minimum standard of Sa 2½ to BS EN ISO 8501-1 : 2007 and BS 7079-A1 : 1989.

# 5 Practicability of installation

Application is designed to be carried out by operatives familiar with this type of product.

# 6 Corrosion resistance

The product has been registered in accordance with the requirements of CG303 and can contribute to corrosion resistance when included as part of the specification for a paint system as listed in the *Supplement to Paints for Corrosion Protection of Structural Steelwork in Highways Applications*.

# 7 Maintenance

Regular planned maintenance may be required as per section 8. Damage can be repaired in accordance with the MCHW, Volume 1 (Paints), Series 5000.

# 8 Durability

A complete paint system based on the products described in Product Sheet 99 can be expected to perform satisfactorily for a period in excess of 15 years before its first major maintenance.

# 9 Application

9.1 Prior to the application of Sigma EP 110 Primer, substrates must be cleaned and prepared in accordance with the MCHW, Volume 1 (Paints), Series 1900 and 5000, and the Certificate holder's instructions.

9.2 The base (Part A) is mixed with a power agitator, the entire contents of the curing agent (Part B) are added, and the product is mixed thoroughly.

9.3 The product is applied by airless spray (tip 0.43 to 0.58 mm, output fluid pressure from 120 to 150 bar) to achieve a typical dry film thickness (dft) of 25 to 35 μm. The Certificate holder can advise on suitable spray equipment.

9.4 Small areas can be coated by brush or roller.

9.5 The product is overcoated with the Certificate holder's products holding the appropriate HAPAS approval, observing the minimum overcoating period given in Table 1.

9.6 The product must be used within the pot life given in Table 1.

## Technical Investigations

## 10 Tests

10.1 Tests were carried out on the liquid paints and the results assessed to determine:

- density
- flashpoint
- volume solids
- viscosity
- volatile organic compound
- pot life
- other composition requirements.

10.2 Tests were conducted on the product as an applied coating and the results assessed to determine:

- opacity of primer, undercoat and topcoat
- colour designation
- visual comparison of primer, undercoat and topcoat colours against the declared standard
- gloss
- time to surface dry (Ballotini)
- time to hard dry
- application and appearance
- minimum overcoating time
- film thickness
- flexibility (topcoats only).

10.3 Tests were conducted on the product as part of a complete system and the results assessed to determine:

- artificial weathering of topcoat
- scratch resistance of single-pack topcoat and of two-pack topcoat
- impact resistance
- adhesion for systems of thicknesses <250 and >250 μm
- resistance to salt spray
- resistance to sulfur dioxide
- resistance to humidity.

# **11** Investigations

The manufacturing process was evaluated, including the methods adopted for quality control, and details were obtained of the quality and composition of the materials used.
