Technical Specification

1 Description

- 1.1 Hempadur Mastic 45880 is a two-pack, high-build, epoxy maintenance undercoat for abraded surfaces comprising a base (45889) and a curing agent (95880), for use as part of a specification for the corrosion protection of structural steelwork in Highway Applications, in accordance with the MCHW, Volumes 1 and 2, where item No 116 is specified. The product is available in two colours: Light Grey (00 A05) (1) and Medium Grey.
- (1) To BS 4800 : 2011.
- 1.2 The product has the following characteristics:

2 Manufacture

- 2.1 The product is manufactured by a batch-blending process.
- 2.2 As part of the assessment and ongoing surveillance of product quality, the BBA has:
- agreed with the manufacturer the quality control procedures and product testing to be undertaken
- assessed and agreed the quality control operated over batches of incoming materials
- monitored the production process and verified that it is in accordance with the documented process
- evaluated the process for management of nonconformities

- checked that equipment has been properly tested and calibrated
- undertaken to carry out the above measures on a regular basis through a surveillance process, to verify that the specifications and quality control being operated by the manufacturer are being maintained.
- 2.3 The management system of the manufacturer has been assessed and registered as meeting the requirements of BS EN ISO 9001 : 2015 by LRQA Denmark (Certificate 00008968).

3 Delivery and site handling

- 3.1 The product is supplied in 5 and 20 litre packs, in the correct proportions. The gross weight of the mixed 20 litre container is 27.5 kg.
- 3.2 The Certificate holder has taken the responsibility of classifying and labelling the product under the *CLP Regulation* (EC) No 1272/2008 on the classification, labelling and packaging of substances and mixtures. Users must refer to the relevant Safety Data Sheet(s).
- 3.3 When stored in its original containers in a paint store in the conditions recommended by the Certificate holder, the product has a minimum shelf-life of 36 months.

Assessment and Technical Investigations

The following is a summary of the assessment and technical investigations carried out on Hempadur Mastic 45880.

Design Considerations

4 Use

Where included as part of the specifications for a paint system as listed in the *Supplement to Paints for Corrosion Protection of Structural Steelwork in Highways Applications*⁽¹⁾, Hempadur Mastic 45880 is satisfactory for use as a primer on:

- steel surfaces prepared by abrasive blast cleaning to surface standard Sa 2½ to BS EN ISO 8501-1: 2007 and BS 7079-A1: 1989, and primed with Hempadur Mastic (AL) 45880-19910 (Item No 115)
- steel surfaces prepared by abrasive blast cleaning to surface standard St3 in accordance with BS EN ISO 8501-1: 2007 and BS 7079-A1: 1989, and primed with Hempadur Mastic (AL) 45880-19910 (Item No 115)
- bright or sound metal coatings primed with Hempadur Mastic (AL) 45880-19910 (Item No 115)
- sound weathered coatings.

5 Practicability of installation

Application is designed to be carried out by operatives familiar with this type of product.

6 Corrosion resistance

The product has been registered in accordance with the requirements of CG303 and can contribute to corrosion resistance when included as part of the specification for a paint system as listed in the *Supplement to Paints for Corrosion Protection of Structural Steelwork in Highways Applications*.

7 Maintenance

Regular planned maintenance may be required as per section 8. Damage can be repaired in accordance with the MCHW, Volume 1 (Paints), Series 5000.

8 Durability

A complete paint system incorporating the product described in this Certificate can be expected to perform satisfactorily for a period in excess of 15 years before its first major maintenance.

Installation

9 Application

- 9.1 Substrates must be cleaned and prepared in accordance with the MCHW, Volume 1 (Paints), Series 1900 and 5000, and the Certificate holder's instructions.
- 9.2 The base is mixed using a power agitator; the entire contents of the curing agent are added, and the product is mixed thoroughly.
- 9.3 The product is applied by airless spray (tip 0.017 to 0.023 inches, output fluid pressure 250 bar), to achieve a dry film thickness (dft) range of 125 to 200 µm. The Certificate holder can advise on suitable spray equipment.
- 9.4 Small areas can be coated by brush, if required.
- 9.5 The product is overcoated with the Certificate holder's products, holding the appropriate HAPAS approvals, observing the minimum overcoating period given in Table 1.

9.6 The product must be used within the pot life given in Table 1.

Technical Investigations

10 Tests

- 10.1 Tests were conducted on the liquid product and the results assessed to determine:
- density
- flashpoint
- · volume solids
- viscosity
- volatile organic content
- pot life
- other composition requirements.
- 10.2 Tests were conducted on the product as an applied coating and the results assessed to determine:
- · opacity of primer, undercoat and topcoat
- · colour designation
- visual comparison of primer, undercoat and topcoat colours against the declared standard
- gloss

- time to surface dry (Ballotini)
- · time to hard dry
- · application and appearance
- · minimum overcoating time
- film thickness
- · flexibility (topcoats only).

10.3 Tests were conducted on the product as part of a complete system and the results assessed to determine:

- artificial weathering of topcoat
- · scratch resistance of single-pack topcoat and of two-pack topcoat
- · impact resistance
- adhesion for systems of thicknesses <250 and >250 μm
- resistance to salt spray
- resistance to sulphur dioxide
- · humidity.

11 Investigations

The manufacturing process was evaluated, including the methods adopted for quality control, and details were obtained of the quality and composition of materials used.
