This HAPAS Certificate Product Sheet⁽¹⁾ is issued by the British Board of Agrément (BBA), supported by National Highways (acting on behalf of the Overseeing Organisations of the Department for Transport; Transport Scotland; the Welsh Assembly Government and the Department for Infrastructure, Northern Ireland), the Association of Directors of Environment, Economy, Planning and Transport (ADEPT), the Local Government Technical Advisers Group and industry bodies. HAPAS Certificates are normally each subject to a review every three years. (1) Hereinafter referred to as 'Certificate'.

This Certificate relates to Interfine 878, a two-pack high-gloss polysiloxane topcoat for use as part of a specification for the corrosion protection of structural steelwork in highways applications, in accordance with the *Manual of Contract Documents for Highways Works* (MCHW), Volumes 1 and 2, where Item No 185 is specified.

Durability — a complete paint system incorporating the product and described in Product Sheet 99 can be expected to perform satisfactorily for a period in excess of 15 years before its first major maintenance (see section 8).

- MCHW⁽¹⁾, Volume 2 Series NG 1900 and NG 5000
- Design Manual for Roads and Bridges (DMRB), CG303 Quality assurance scheme for paints and similar protective coatings
- CM 431, formerly BD 87/05.

Technical Specification

1 Description

1.1 Interfine 878 is a two-pack, high-gloss, polysiloxane topcoat, for use as part of a specification for the corrosion protection of structural steelwork in Highway Applications, in accordance with the MCHW, Volumes 1 and 2, where item No 185 is specified. The product is available in a range of colours, details of which are available from the Certificate holder's Chromascan process. The white colour is outside the scope of this Certificate.

1.2 The product has the following characteristics:

1.3 International GTA007 is used to thin the product prior to application, and for the cleaning of equipment.

1.4 Other products for use as part of the complete paint system are given in Product Sheet 99.

2 Manufacture

2.1 The product is manufactured by a batch-blending process.

2.2 As part of the assessment and ongoing surveillance of product quality, the BBA has:

- agreed with the manufacturer the quality control procedures and product testing to be undertaken
- assessed and agreed the quality control operated over batches of incoming materials
- monitored the production process and verified that it is in accordance with the documented process
- evaluated the process for management of nonconformities
- checked that equipment has been properly tested and calibrated
- undertaken to carry out the above measures on a regular basis through a surveillance process, to verify that the specifications and quality control being operated by the manufacturer are being maintained.

2.3 The management system of the manufacturer has been assessed and registered as meeting the requirements of BS EN ISO 9001 : 2015 by LRQA Registered Nederland B.V (Certificate 10211449).

3 Delivery and site handling

3.1 The product is supplied in either a 5 or 20 litre pack, each of which contains the correct proportions of each component. The gross weights of the mixed containers are 7.3 and 29.2 kg respectively.

3.2 The Certificate holder has taken the responsibility of classifying and labelling the product under the *CLP Regulation (EC) No 1272/2008 on the classification, labelling and packaging of substances and mixtures.* Users must refer to the relevant Safety Data Sheet(s).

3.3 When stored in its original containers in a paint store in the conditions recommended by the paint manufacturer, the base will have a minimum shelf-life for 12 months and the curing agent will have a minimum shelf-life for 6 months.

Assessment and Technical Investigations

The following is a summary of the assessment and technical investigations carried out on Interfine 878.

Design Considerations

4 Use

Where included as part of the specification for a paint system as listed in the *Supplement to Paints for Corrosion Protection of Structural Steelwork in Highways Applications*⁽¹⁾, Interfine 878 is satisfactory for use as a top coat of a corrosion protection system for structural steel.

5 Practicability of installation

Application is designed to be carried out by operatives familiar with this type of product.

6 Corrosion resistance

The product has been registered in accordance with the requirements of CG303 and can contribute to corrosion resistance when included as part of the specification for a paint system as listed in the *Supplement to Paints for Corrosion Protection of Structural Steelwork in Highways Applications*.

7 Maintenance

Regular planned maintenance may be required as per section 8. Damage can be repaired in accordance with the MCHW, Volume 1 (Paints), Series 5000.

8 Durability

A complete paint system incorporating Interfine 878 and based on the products described in Product Sheet 99 can be expected to perform satisfactorily for a period in excess of 15 years before its first major maintenance.

Installation

9 Application

9.1 Substrates must be cleaned and prepared in accordance with the MCHW, Volume 1 (Paints), Series 1900 and 5000, and the Certificate holder's instructions.

9.2 The base (Part A) is mixed with a power agitator, the entire contents of the curing agent (Part B) are added, and the product is mixed thoroughly.

9.3 Interfine 878 is applied by airless spray (tip range from 0.28 to 0.43 mm, output fluid pressure from 15.5 bar) or airassisted spray, to achieve a typical dry film thickness (dft) of 50 to 75 μ m [equivalent to a wet film thickness (wft) of 69 to 104 μ m]. The Certificate holder can advise on suitable spray equipment.

9.4 Small areas can be coated by brush or roller, if required.

9.5 The product is overcoated with the Certificate holder's products holding the appropriate HAPAS approval, observing the minimum overcoating period given in Table 1.

9.6 The product must be used within the pot life given in Table 1.

Technical Investigations

10 Tests

10.1 Tests were carried out on the liquid product and the results assessed to determine:

- density
- flashpoint
- volume solids
- viscosity
- volatile organic compound
- pot life
- other composition requirements.

10.2 Tests were conducted on the product as an applied coating and the results assessed to determine:

- opacity of primer, undercoat and topcoat
- colour designation
- visual comparison of primer, undercoat and topcoat colours against the declared standard

- gloss
- time to surface dry (Ballotini)
- time to hard dry
- application and appearance
- minimum overcoating time
- film thickness
- flexibility (topcoats only).

10.3 Tests were conducted on the product as part of a complete system and the results assessed to determine:

- artificial weathering of topcoat
- scratch resistance of single-pack topcoat and of two-pack topcoat
- impact resistance
- adhesion for systems of thicknesses <250 and >250 μm
- resistance to salt spray
- resistance to sulfur dioxide
- resistance to humidity.

11 Investigations

The manufacturing process was evaluated, including the methods adopted for quality control, and details were obtained of the quality and composition of the materials used.
