**8.2. Exposure controls****Personal protection measures, such as personal protective equipment**

Use personal protective equipment that is clean and has been properly maintained.

Store personal protective equipment in a clean place, away from the work area.

Never eat, drink or smoke during use. Remove and wash contaminated clothing before re-using. Ensure that there is adequate ventilation, especially in confined areas.

**- Eye / face protection**

Avoid contact with eyes.

Use eye protectors designed to protect against liquid splashes
