4. FIRST AID MEASURES

GENERAL In all cases of doubt or when symptoms persist seek medical attention. Never give anything by mouth to an unconscious person.

INHALATION

EYE CONTACT Contact lenses should be removed. Irrigate copiously with clean, fresh water for at least 10 mins. holding the apart, seek medical advice.

6. ACCIDENTAL RELEASE MEASURES

Contain and collect spillages with non-combustible absorbent materials e.g. sand, earth and place in suitable container for disposal in with the waste regulations Clean preferably with a detergent, avoid use of solvents.

7. STORAGE & HANDLING

Storage

Observe the label precautions. Store between 5 & 25°C in a dry well ventilated place away from sources of heat, ignition and direct smoking. Prevent unauthorised access. Containers which are opened should be properly resealed and kept upright to prevent leakage. Store away

from oxidising agents and strongly alkaline or acid materials.

Handling

Avoid skin & eye contact. For personal protection see Sect.8. Good housekeeping, regular maintenance of spray booth filters, and regular removal of waste materials will minimise risks.
